One breeding dose equals 8 straws, so the mare owner will receive as a shipment a total of 16 straws per one cycle. This is for insemination on **1** mare. Any doses not used after a mare is pronounced in foal shall be returned immediately to Select Breeders. If the mare is **NOT** confirmed in foal, single doses will be available at \$500. per dose. Live Foal Guarantee with no booking fee, but additional dosing and shipping fees will apply. Buyer can only register one foal unless buyer pays for additional breeding fees.

- **Payments shall be made payable to: THE STABLES OF FIELDCREST and sent to 7995 Shady Stone Street N.W., Massillon, Ohio 44646, along with this executed signed contract & a copy of the Mare's current registration papers.**
- **Shipments will be made from Select Breeders Services, Inc., 961 Cayots Corner Rd Chesapeake City, MD. 21915. The buyer shall be responsible for shipping fees and all corresponding charges that will be charged by Select Breeders. Buyer agrees to make full payment to Select Breeders Services Inc., upon shipment.**
- **Buyer will be responsible to contact Select Breeders Services @ 410-885-3202 to arrange shipping.**

Before semen can be shipped, Mare Owner shall provide a report to The Stables of Fieldcrest issued by a licensed veterinarian, that is dated no earlier than 30 days prior to the shipment of semen stating that a licensed veterinarian has examined the Mare and that the result included a negative uterine culture. Your mare should be current on vaccinations.
